

An attractive two bedroom, mid-terrace stone cottage with beamed ceilings, situated over three floors within the Conservation area of Kirkbymoorside, currently used as a holiday cottage. Accommodation on the ground floor includes sitting room with multi-fuel stove, a modern kitchen runs through to the high ceiling dining room with skylight and double doors opening on to the terraced patio. From the first floor there is a well proportioned double bedroom, a modern shower room with large walk in shower and a door leading to the staircase accessing the second floor bedroom with a beamed cathedral style ceiling. Electric heating.

Externally a hard landscaped terrace patio, ideal for enjoying light evening nights and eating alfresco.

Kirkbymoorside is an ancient market town with a good range of amenities, including a doctors and dentists surgery. The outstanding North York Moors National Park is only a short drive away. The ancient city of York and the coastal resorts of Scarborough and Whitby are easily commutable.



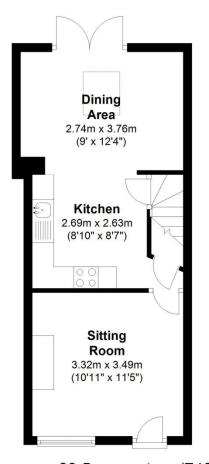
