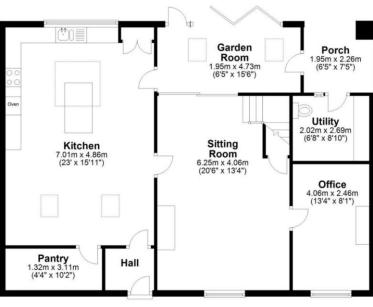


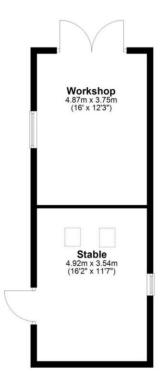






Ground Floor Approx. 99.2 sq. metres (1067.6 sq. feet)





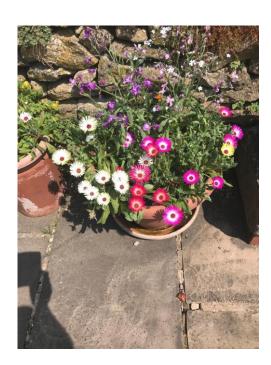




First Floor
