Gas fired central heating, double glazed windows.

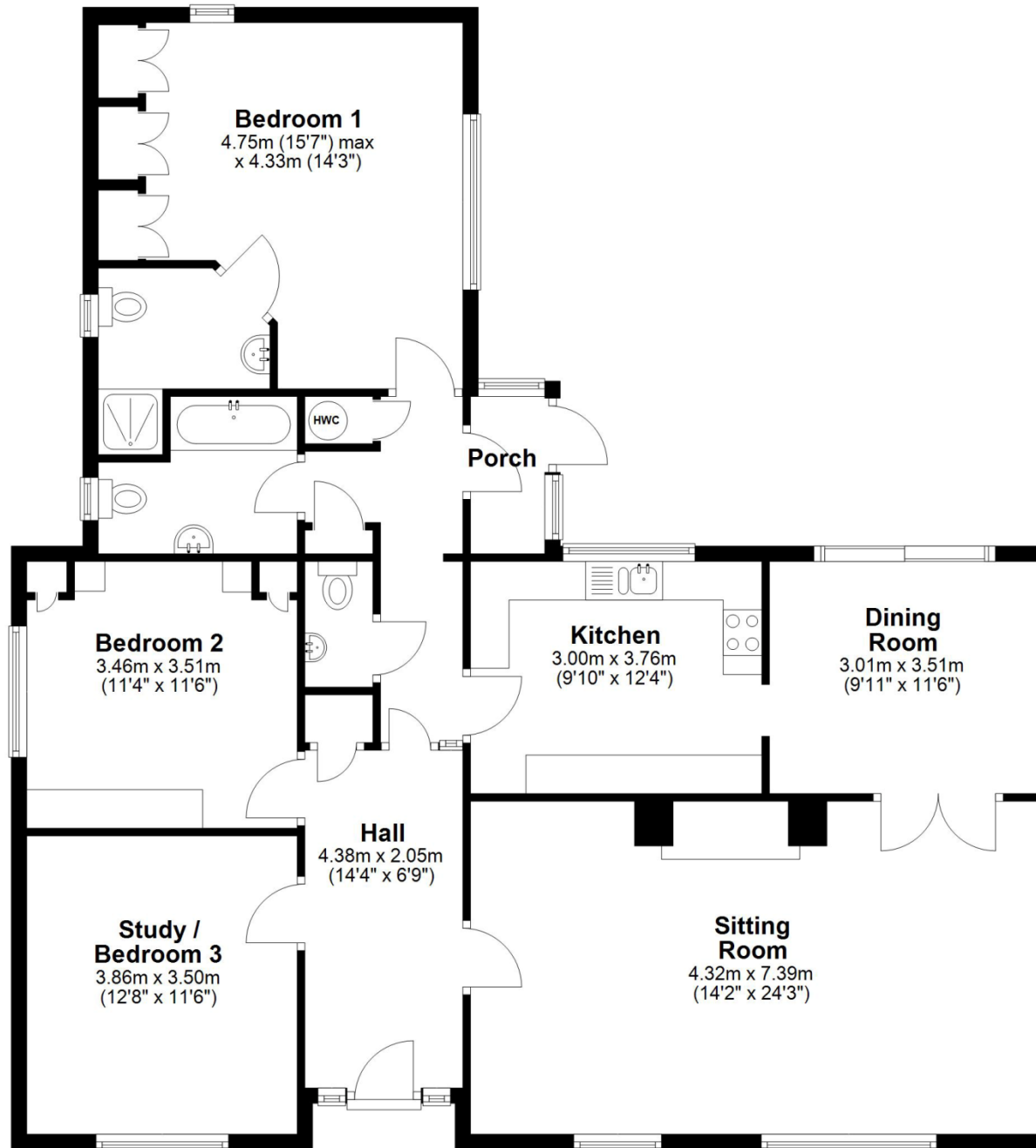
The property is approached by a shared tarmaced drive with the adjoining property and this leads through to The Rowans.
