Ground floor: Front entrance hall, sitting room, inner hall, cloakroom/utility room, fitted kitchen/dining area, conservatory.

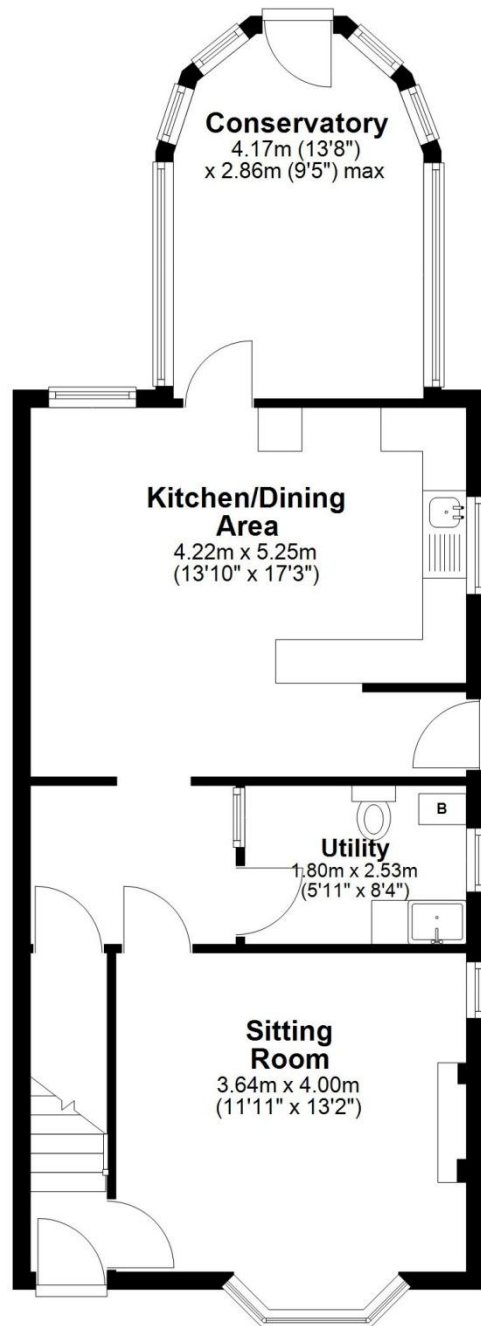
First floor: Landing, three bedrooms and house bathroom with shower over bath.

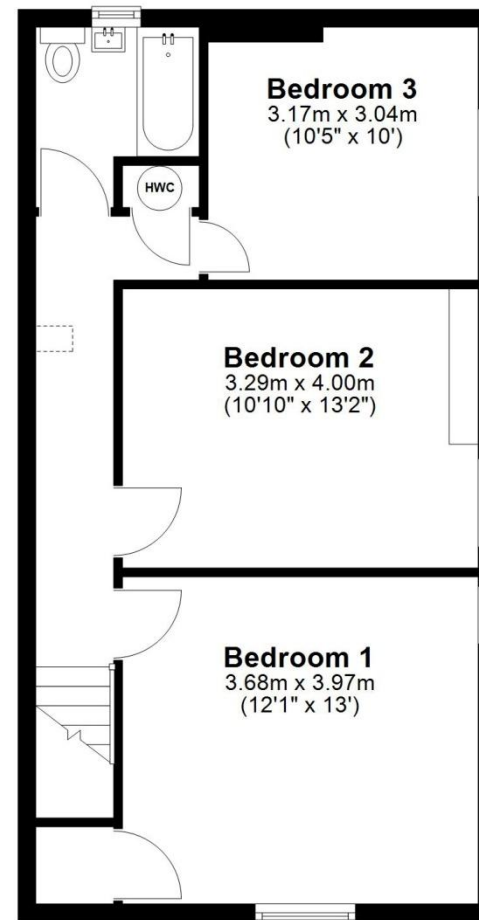

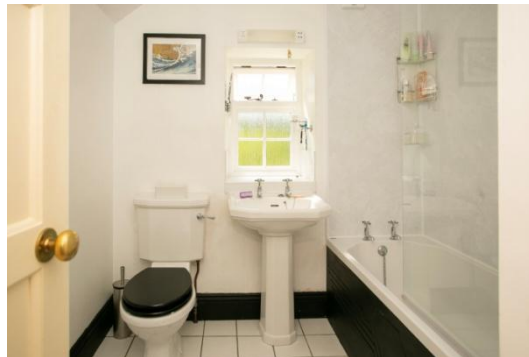
