Daisy Cottage: Kitchen/dining area, sitting room, Bedroom and en-suite spacious shower room


Lavender Cottage has a generous rear garden with an equally attractive hillside wooded back drop. Access from the back lane leads to the double garage and generous car standing area.




First Floor


